Xh.Murati (2001, p.16). So, the family life is the source of all positive or negative traits of child's character, and how that child will behave in society depends on the education acquired in the family. At the younger children the traits of character are educated through positive or negative impact of family life and relationships in it. This is the reason why many behaviors of a child usually are associated with bad or good reports that exist in the family. Harmony of family life is an essential educational element which avoids indifference, encourages moral feelings and promotes positive human qualities. Xh. Murati (1998, p.328)

Child's strong personality is basically formed under the influence of an organized education and well guided (led) as in family also in and out of school. R. Brada (1995, p.234)

Recently, many reviews are done for the family, the relations between the spouses, the relationship between parents and children, and problems arising continuously from these relations. In these reports within the family members are created major changes and have mostly the opposite view and consequently appear different type of problems.

Integral parts of education in the development of the child

The majority of family researchers, in whose works addressed this issue important factor in child development, point in its complexity and educational work are elements that have a significant effect on negotiability of several problems facing individual.

Family can be calculated as a social institution, which should give special contribution in shaping the personality of the child. It operates as a unit of society and is some small organizational unit the district in the middle of broad social, cultural and family on one side and the other. - To help in the development of the child's consciousness and moral thoroughness
- To help the strong moral character. R. Brada (1995, p.219)

The esthetic development differing from the other educational aspects, during its realization requests esthetic - spiritual stimulation. This on the other hand, imposes the reason of following the logics for the evocation of the beauty. Xh. Murati (2001, p.276). Therefore, the family is the main factor which could help the children to develop and revive the esthetical element and the evocation of the beauty.

The working development deserves to be treated as an element, which requests maximal commitment from the side of the parents to be transformed and educated in the children because through the work the children develop in physical, psychical and social aspect.

Therefore the problems of children education and development need to be analyzed even more as primary plan problems in the family and the necessity of a serious preoccupation and with clear intensions makes us realize the importance and the value of the child's education and development in the family.

So, in our society, the role of the family literacy is very high, because the family which is built upon respect on each – other, based on their love then the feeling of parents' responsibility towards their children is very high.

Conclusion

So, to understand the role of the family, for the formation and the development of child's personality we will refer to the opinion of a very precious academic Jashar Rexhepagic, that the educative role in the family doesn't disappear, and it cannot be undervalued as well. J.Rexhepagic, p.75)

Finally we can say that the educative role of the family is in over dominance above all the other factors even emphasizing that the interest of the parents and the family it is in the education and the development of the children as a primary and deterministic duty.

The changes and the social development are possible together with the changes of this process because the young generation is inheriting from the older ones an assigned material, cultural development, specific behavioral ways, conviction and orientations, cultural values, and these inherited elements change and create new values and relations.

It is very important to know the personality of the children because it should participate in all forms of the organization and types of educational activities.
